

Allianz "25th Anniversary, 25% Discount" Campaign Terms and Conditions

Allianz 25th Anniversary, 25% Discount Campaign ("Campaign") is organised by Allianz General Insurance Company (Malaysia) Berhad ("**AGIC**") and shall be subject to the terms and conditions contained herein.

1. Campaign Period

This **Campaign** will run from 4th September 2026 until 18th September 2026 ("**Campaign Period**"). Notwithstanding the aforesaid, **AGIC** reserves the right to change the **Campaign Period** without prior notification.

2. Eligibility

To be eligible to participate in this **Campaign**, the following criteria must be met:

- a) The individual policyholder must be covered under a Domestic or Overseas single-trip coverage (and not an annual coverage) under the Allianz Travel XPert ("**ATX**") or Allianz Travel Easy ("**ATE**").
- b) The **ATX** or **ATE** policy must have been purchased during the **Campaign Period**.

The policyholders who fulfil the criteria above will be deemed as the eligible participants ("**Eligible Participants**") and will enjoy a discount on the premium for their **ATX** or **ATE** policy, subject to the **Campaign** Terms and Conditions.

3. Campaign Terms and Conditions

- a) This **Campaign** shall not be applicable to the **ATX** or **ATE** policies issued on an annual coverage basis.
- b) **Eligible Participants** shall be entitled to a twenty-five percent (25%) discount ("**Discount**") on the basic premium payable excluding any rider(s) for their **ATX** or **ATE** policy if they fulfill the criteria of this **Campaign**.
- c) The **Discount** can be applied by using the code **ALLIANZ25** during the purchase of the **ATX** or **ATE** policy.

- d) In the event the **Eligible Participant** purchases more than one (1) **ATX** or **ATE** policy during the **Campaign Period**, he/she shall be entitled to the **Discount** for each **ATX** or **ATE** policy.

4. Other Conditions

- a) By participating in this **Campaign**, the **Eligible Participants** hereby agree to be bound by the terms and conditions stipulated herein and all decisions made by **AGIC** in respect of this Campaign which shall be final and conclusive.
- b) **AGIC** reserves the absolute right and discretion to cancel, terminate or suspend this **Campaign** or vary its terms and conditions without any prior notice or reason. For the avoidance of doubt, the **Eligible Participants** hereby agree that they are not entitled to any form of compensation whatsoever arising from any losses or damages incurred as a direct or indirect result of the said cancellation, termination, suspension or variation by **AGIC**.
- c) **AGIC** shall not be liable for any direct or indirect loss or damage of any kind howsoever arising, suffered by the **Eligible Participants** or any person claiming through the **Eligible Participants** in connection with this **Campaign**.
